A BY-LAW OF THE MUNICIPALITY OF FREDERICTON JUNCTION
RESPECTING THE ESTABLISHMENT OF A MACHINERY AND EQUIPMENT
DEPRECIATION RESERVE FUND

The Council of the Municipality of Fredericton Junction duly assembled enacts as follows:

INTERPRETATION

1. In this By-Law "Reserve Fund" means a machinery and equipment depreciation trust fund for the replacement of Municipalities machinery and equipment.

RESERVE FUND

2. Pursuant to subsection 90(4) of the Municipalities Act, the Council of the Municipality of Fredericton Junction hereby establishes a Reserve Fund.
3. Council shall determine annually on or before December 31 by by-law the amount of money to be transferred to the Reserve Fund, the amount for 1983 shall be twenty thousand (20,000.00) dollars.
4. Such monies shall be invested in a separate account in accordance with subsection 90(a) of the Municipalities Act.
5. Such monies shall be used only to purchase replacement machinery or equipment and not otherwise except with the approval of the Commissioner of Municipal Affairs.

A BY-LAW OF THE MUNICIPALITY OF FREDERICTON JUNCTION
RESPECTING THE ESTABLISHMENT OF A MACHINERY AND EQUIPMENT
DEPRECIATION RESERVE FUND

The Council of the Municipality of Fredericton Junction duly assembled enacts as follows:

INTERPRETATION

1. In this By-Law "Reserve Fund" means a machinery and equipment depreciation trust fund for the replacement of Municipalities machinery and equipment.

RESERVE FUND

2. Pursuant to subsection 90(4) of the Municipalities Act, the Council of the Municipality of Fredericton Junction hereby establishes a Reserve Fund.
3. Council shall determine annually on or before December 31st by By-Law, the amount of money to be transferred to the Reserve Fund, the amount for 1985 shall be fifteen thousand (15,000.00) dollars.
4. Such monies shall be invested in a separate account in accordance with subsection 90(a) of the Municipalities Act.
5. Such monies shall be used only to purchase replacement machinery or equipment and not otherwise except with the approval of the Commissioner of Municipal Affairs.

BY-LAW # 20B

A BY-LAW OF THE MUNICIPALITY OF FREDERICTON JUNCTION

**RESPECTING THE ESTABLISHMENT OF A SNOW REMOVAL
RESERVE FUND**

The Council of the Municipality of Fredericton Junction duly assembled enacts as follows:

INTERPRETATION

1. In this By-Law "Reserve Fund" means a Snow Removal Fund for the removal of snow within the Municipality.

RESERVE FUND

2. Pursuant to subsection 90(4) of the Municipalities Act, the Council of the Municipality of Fredericton Junction hereby establishes a Reserve Fund.
3. Council shall determine annually on or before December 31st by By-Law, the amount of money to be transferred to the Reserve Fund, the amount for 1988 shall be ten thousand (10,000.00) dollars.
4. Such monies shall be invested in a separate account in accordance with subsection 90(3.1) of the Municipalities Act.
5. Such monies shall be used only for the removal of snow and not otherwise except with the approval of the Commissioner of Municipal Affairs.
