- Dillon Consulting Update on PW4 Turbidity Monitoring
 - Requirement may be removed if proof can be shown that it is not GUDI (Groundwater Under Direct Influence of Surface Water).
 - Burden of proof could take 1+ year process for MPA testing and it may be less costly to put the monitoring system in
 - Dillon Consulting is continuing to look into this issue
- Two quotes from one company have been received for heat pumps for the Fire Department
 - Ask the Fire Chief if he received a quote from a second company
