CRSC

- Attending the CRSC Winter forum with Deputy Mayor Hartt at the Delta. The Minister of Local Government will be there
- Next CRSC meeting will be January 30th, 2025
- CRSC has moved to a new location but not open to the public yet
- Will be attending and reading for a literacy program on January 24th, 2025
- We had a discussion at our last meeting about DTI and snow plowing and I have spoke with Matt Harris
 and Son and it would be the same price to hire them for snow plowing as we are paying DTI for Winter
 Maintenance and it would be done earlier
 - DTI has been down a lot of their equipment and need to send their trucks to town for fixes
 - Matt Harris and Son has the equipment for snow plowing
 - DTI already hires Matt Harris and Son for roads they can't get to
 - · Will need to look into DTI Winter Maintenance and exactly what that entails
- We need more Seniors housing and to have more conversations about it
 - Will find out more about the process, funding and developers

- ELG approved our 2025 General and Water and Sewer Budgets
- Next will be the 2024 Audit
 - · Already signed the engagement letter and bank forms for Shannon and Buffet

Community & Health Affairs

- The Events Committee Chairperson is myself, Councillor Hartt, it falls under my portfolio. To date we have two committees that report to us: Come Home Week and Sunbury Snowblast (formerly Frostival). Both committees are made up of members of the Tri County Communities not just residents of Fredericton Junction. In the past we have stood up adhoc committees for special recognition events (i.e. 50th anniversary of VFJ being incorporated, Come Home Week 50th Anniversary). We will continue to do so as special events come up but for now we only have these two.
- Sunbury Snowblast had a meeting at the Legion on January 7th, 2025
 - It is a full schedule and the actual events are going to start on February 12th with the Sweetheart dinner at the Curling Club, but we are still advertising the weekend events from February 14th-17th, 2025
 - The sleigh ride will cost \$300 more this year and we are waiting to see if Tracy would like to cost share that with us. Councillor Shelly Nowlan was taking this before them
 - · Family Skate sponsorship that we do for this with a hot dog and warm drink. Tri
 County will look into this and make sure everyone will get a treat
- The Come Home Week fireworks will go ahead on February 16th, 2025
- Healthcare Recruitment meeting will be January 20th, 2025
 - · Presentation by Dr Chatur Virtual healthcare appointments
- Welcome Wagon- it is exciting that new community members are for information about what is available in our area
- Magical Comedy Night at the Curling Club on January 24th, 2025, was asked to publicize by the Curling Club on our website and facebook
- Filing project ordered a rolling storage cart for blueprints and CRSC will digitalize them
- Agree to have CRSC will be able to help us deal with overdue/delinquent water bills
- Water Rates
 - Look at Policy and By-Law
 - · Water bills unpaid over 90 days need to be dealt with
 - A serious look at water rates needs to happen due to rising cost of operating that utility
