BY-LAW # 2024-05 A BY-LAW TO AMEND BY-LAW 2012-02 OF THE MUNICIPALITY OF FREDERICTON JUNCTION RESPECTING THE PROCEDURE AND ORGANIZATION OF THE VILLAGE OF FREDERICTON JUNCTION BY REPEALING SECTIONS 1 (a,b,c,e,f,g,h &i), 4(7), 14, 38, 39 & 40 WITH RESPECT TO DEFINITIONS, THE COUNCIL MEETING AGENDA, VOTING, AND THE APPOINTMENT AND ORGANIZATION OF COMMITTEES REPLACING WITH NEW Title change: UNDER THE LOCAL GOVERANCE ACT THE COUNCIL OF THE VILLAGE OF FREDERICTON JUNCTION, DULY ASSEMBLED, HEREBY ENACTS AS FOLLOWS: Amendments to By-Law: 2012-02: 1. Sections #1 (a,b,c,e,f,g,h &i ) 1. In this by-law (a) "act" means the Local Governance Act (b) "clerk" means the clerks of the municipality appointed under section (71 Local Governance Act) (c) "corporation "means the local government. (d) "committee" means a committee provided for or created by Council. (e) "council" means the mayor and councilors, of local government. (f) "councilor" means a member of the council other than the mayor; (g) "member of council" means a mayor or a councillor; (h) "municipality" means a city, town or village (the Village of Fredericton Junction). (i) "quorum" means a majority of the full number of members of council. and #4 (7) of By-Law 2012-02 are hereby repealed and replaced with the following: 4 (7) The clerk shall make available to each member, not later than the Thursday before the day fixed for each regular meeting, the agenda of the meeting and the minutes of the previous meeting. and #14 of By-Law 2012-02 are hereby repealed and replaced with the following: 14. All councilors shall

vote on all matters as per section 66 (1) (2) of the Local Governance Act. In the event of a tie vote, the Mayor shall cast the deciding vote. The mayor shall only vote in the event of a tie and at no other times unless required to under the Provincial statutes. and #38, #39 and #40 of By-Law 2012-02 are hereby repealed and replaced with the following: 38. Council may establish and abolish committees. Council shall approve the mandate of each committee. Section 48(2) The Mayor may make suggestions to such committees. Council may also constitute special or ad hoc committees and appoint persons thereto. These are decisions of council and must be voted on. Section 48(2) 39.At the inaugural meeting of council, a chairperson for each committee shall be decisions of council. Section 48(2) 40.It is a decision of Council to appoint a member of the Municipality, who is qualified to be a candidate in a municipal election as defined by the Municipal Elections Act. (Section 48(2) (Municipalities Act Section 18 (1) (2) a,b,c,d (3) (3.1) (4))
